Eligibility Criteria	The Bidder shall be a Company which is designing, sourcing, supplying and executing this project with a minimum of 5 years of experience in the relevant business pertaining to the equipment range mentioned in the tender. The bidder shall have successfully designed, supplied and installed atleast 3 same/similar facilities of such characteristics in the last 5 years. Average annual turnover for last three financial years (FY 2015-16, 16-17 & 17-18) shall equal/higher than the value mentioned in the Annexure A , against each package.
